- 2. Discussion and possible action-Review Quotes from Kinetic Solutions-RE: Security and Video Equipment for Town Office. Discussion to wait on the other quotes until the new budget season. Mayor made a motion to approve the Quote for \$9650.00 that allows for streaming equipment and the quote for \$5435.00 to upgrade the router and security network. Ask accountant to transfer \$8000.00 out of legislature to the clerk budget. Move \$3000.00 from equipment supplies and maintenance in the Town Managers budget to clerk. Move \$2500.00 from the town manager equipment budget to the clerk. The clerk has 1000.00 in the budget to use to fund the purchase of the requested equipment. Funds are to be moved to the capital outlay equipment line in the clerk's budget. Councilor Ballard second all in favor.
- 3. Discussion and possible action-Review Sweetwater Stonework & Rain Gutter Company Quote- Gutters for the Marshalls Office. Discussion to use the funds allocated to the Marshall's office last council meeting for the grappler equipment that was approved but then canceled to pay for the rain gutters. The funds were coming out of the contingency fund. Motion by Councilor Ballard to approve the Rain Gutter quote in the amount of \$4150.00 with the funds to come out of the contingency fund seconded by Councilor Johnson all in favor.
